- 4. The Fees for **LITTER REGISTRATION of GSD Breeds** is **Rs.1000/-** per pup within 60 days / **Rs.1500/-** per pup from 61 days to 120 days and **Rs.2500/-** per pup from 121 days to 180 days (including GST)
- 5. The Fees for **LITTER REGISTRATION of Indian Breeds** is **Rs.375/-** per pup within 60 days / **Rs.600/-** per pup from 61 days to 120 days and **Rs.1000/-** per pup from 121 days to 180 days. (including GST)
- 6. Litters can ONLY be REGISTERED by the BREEDER at this fee provided the following conditions are fulfilled:
 - BOTH the SIRE and DAM of the puppies must be registered with the K.C.I. and the BREEDER is recorded as the OWNER of the DAM.
 - (ii) Application for Registration of ALL THE LIVE PUPPIES is submitted at ONE and the SAME TIME after 30 days of birth.
 - (iii) The particulars in the DECLARATION below should be FILLED IN and SIGNED by the OWNER / BREEDER. Failure to complete and sign the declaration below will render the application liable to be returned.
- 7. NAMING THE DOGS: Before choosing names for dogs to be registered, owners are requested to note CAREFULLY the following CONDITIONS and to give TWO NAMES for each dog to be registered so that in case the first choice inadmissible, the dog may be registered in the alternative name.
 - (i) The Name of notable persons, titles, kennels, countries, large towns, common names, well known dogs abroad, or numbers in figures or words should not be selected.
 - (ii) A Name or Names excluding a Registered Prefix / Affix shall not be exceeded twenty four letters.
 - (iii) A word SHALL NOT be used in the name of MORE THAN ONE DOG unless the same is registered as a Prefix / Affix.  - (iv) Application for Registration of Prefix / Affix must be in the prescribed form. The Fee for Registration of a PREFIX / AFFIX is Rs.10,000/- which is for life. (with GST)
 - (v) Owners who desire to register a Prefix / Affix should be an IKG subscriber, In addition to their first choice should give atleast TWO alternatives so that should their first choice be already registered or inadmissible, one of the alternatives may be selected.
- 8. The DECLARATION ON THE REVERSE and BELOW in case of litter Registration (see Note 3 above) must be signed by all the owners in case of JOINT ownership.
- 9.
